The Council Approval and Certification Section was now required to be signed by the Clerk and formally approved by Council for signature by the Mayor. Members were shown a virtual copy of the return.

Members confirmed the following: The Approval and Certification Section on page 4 of the Annual Return is to be signed by both the Mayor and Clerk. As the Council meeting was held by video conference, the Clerk to obtain the signature of the Chair of Council on the Annual Return in due course.

10(G). 120/21 STREETSCENE SCHEDULE (FLINTSHIRE COUNTY COUNCIL)

Members brought the following concerns to the meeting:

- (1) Disabled parking bay, adjacent to Town Square bus shelter. The yellow line markings have faded considerably; could they be re-painted?
- (2) Pot holes: B5122 road travelling out of Caerwys towards A55 just past St. Michael's entrance; the pot holes on both sides of the road have increased in both depth and circumference since last reported.
- (3) Pot holes: B5122 Caerwys Hill in area of Caerwys View Holiday Park; the pot holes on both sides of the road have increased in both depth and circumference since last reported.
- (4) Pot holes: B5122 bottom of Caerwys Hill in Afonwen and also turning right towards Denbigh.
- (5) Tarmac broken up: B5122 road at roundabout opposite Dragon's Rest Café.
- (6) Cobbled area of the Town Square. Could the area be sprayed with weedkiller?
- (7) There are a number of streets leading from the Town Square and the B5122 in Caerwys, including Pen Y Cefn Road whereby weeds are in abundance. Could the areas be sprayed?

The Clerk advised that the above concerns would be brought to the attention of StreetScene.

11(A). 121/21 TOWN MAYOR'S REPORT

The Immediate Retired Town Mayor, Councillor Steve Copple, provided the following report:

A meeting was held on 13th May with members of FCC highways team and Council members, Howard Griffiths, Steve Copple and County Councillor Tudor Jones. Ysceifiog Council was also represented.

Several designs were shown that reflected the discussions on the previous meeting. These areas of potential improvement to pedestrian safety centred on additional paving in the area of the town square and the junction of water street and north street. Additionally a centre of the road "bollard" was also shown near the entry to the new housing estate. The purpose of these design drawings was to ascertain technical feasibility. In addition poor parking on several junctions along north/south street have been the cause of concern and it was proposed to have restricted parking in these areas. It was noted that such restriction's will need enforcement. The meeting discussed costs and funding opportunities and a ball park estimate of £50000 was mentioned to complete the task. The work to

obtain funding was explained as being a challenge but the with good planning and timely consultation FCC have been successful in the past in attracting funding from various sources. The overall meeting was well managed and attendees were impressed with the work done by FCC to move ahead with the process.

COUNTY COUNCILLOR'S REPORT (CLLR TUDOR JONES)

County Councillor Tudor Jones provided Members with the following report:

Ysgol Yr Esgob Church in Wales VA school. Ysgol Lixwm VA school:

The new interim Governing body met last night 17th May to finalise details for the full federation of both schools.

A new 19 strong single governing body has been agreed and the process of advertising for Parent Governors will be started. This will require an election if more than the candidates required are nominated.

The interim Governing body will meet once again in June.

Wrap -around Child Care

The Planning process for the new Wrap-around Child Care facility [Clwb Bwthyn Bach] has started but the application is not yet open for comment.

Ffridd y Gareg Wen

The untidy state of the area along roadside at Ffridd y Gareg Wen has been reported to Planning enforcement and letter written to the land owners [Mostyn Estates] but no reply received yet. Enforcement Officer has written again today.

Pedestrian Safety scheme. Talks with Highways have continued [2 meetings so far]. Highways are positive for the potential of progress. Two draft proposal plans were shown virtually to Members.

Road repairs are logged and progress can hopefully be made with the following:

Resurfacing between the Piccadilly and the 30mph early warning sign.

Holes on Caerwys Hill to be filled.

Entry to Bryn Llwyd in Caerwys to have pavement restored and drain mended to prevent flooding. Flooding at Marian Bach. Soakaway has been jet-washed, damaged drain identified, and an additional soakaway is being considered.

Major damage to Maes Mynan road. Looking into potential of adding onto another job on the A541 to complete at same time.

New Summerhill estate:

Occupancy delayed from March. Required a sign-off from Welsh Water to make final connection to fresh and foul water system in North Street. Now signed off but no application made for permit to close the road yet. Delay creating difficulties for new owners.

Leisure Centre & Library

Now reopened but under restricted numbers. Café to reopen next week. Library open. New website in operation.

Keeping in Touch:

Annual Newsletter [Focus] delivered across most of ward. Still some outlying areas to finish.
