3. 187/23

PUBLIC QUESTIONS, COMMENTS OR REPRESENTATIONS

- (1) Concern expressed by resident that the grass cutting on the football pitch adjacent to the play area in Chapel Street had not been completed fully. The grass had been cut up to the edges of the pitch perimeter but not the actual pitch. This resulted in the pitch not being playable by the youths during the summer holidays. A similar occurrence to last year. Members were shown a photograph of the part cut grass on screen (Minute number 7(G). 198/23 (i) on page 7 below).
- (2) Letter received from resident who wished the following concerns to be brought to the attention of the Town Council:
 - The developers of the properties being constructed on the former Summerhill Farm and in particular, on Pen Y Cefn Road, to be requested not to remove any further hedgerow.
 - The Old Watering Trough in Caerwys requires remedial work
 - To seek that Flintshire County Council cease their quest for a 20mph speed reduction.

The Clerk advised that he had replied as follows: (i) The removal of the hedge was granted during the planning process (ii) To provide further information as to the area of the watering trough (iii) The 20mph reduction is a Welsh Government initiative which will be in force from Sunday 17th September.

(3) Concern expressed from resident in relation to the mini roundabout on the B5122 road at the junction with the A55 flyover (Dragon's Rest). In particular, a request for white road arrow markings on each side of the carriageway – one to turn left and the second to drive over the flyover. Members were shown a Google street view of the junction. (Minute number 7(G). 198/23 pages 7 & 8 below).

The Minutes were proposed as correct by (i) Councillor Jonathan Duggan-Keen and seconded by Councillor Peter Dooley (ii) Councillor Steve Copple and seconded by Councillor Susan Broadaway (iii) Councillor Lynette Edwards and seconded by Councillor Lesley Roberts, with the three sets of minutes thereafter formally agreed by the Members present.

6(A). 190/23

PROGRESS REPORT ON MATTERS RAISED AT PREVIOUS MEETINGS

The Clerk referred to the following matters from previous Minutes:

- (1) Visit by Hannah Blythyn MS / AS to the July Council meeting. The Clerk recollected Members to an e-mail received from the Welsh Government Member that was forwarded to Councillors. The mail advised that when responses had been received from Flintshire County Council and the Police further contact with the Town Council will be made.
- (2) Harp Project: The Clerk advised that a quotation had been received from Flintshire County Council for the groundworks to enable the Harp to be erected, at a cost of £4,302.18. The Town Council were still awaiting an updated scale marked plan to include with a planning application; Councillor Steve Copple has further sought this.

Members agreed the following: (1) Accepted the above referred to quotation from Flintshire County Council for £4,302.18 (2) Members suspended financial standing orders in relation to seeking more than one quotation for the following reasons: The site area for the Harp is County adopted highway; the County have provided the plans at no cost to this Council, which will ensure that the planning application is considered in an expedited manner. The Clerk to issue a Work Order, with a note advising – pending planning permission.

(3) Afonwen Notice Board: The Clerk advised Members that a quotation for a new board had been received from Apex Joinery (NW) Limited at a cost of £940.00 plus VAT £188,00 – total £1,128.00. The quotation was shown on screen.

Members agreed the following: The Clerk to issue a Work Order to Apex Joinery (NW) Limited for the sum if £1,128.00 (inc VAT).

(4) Audit Wales: The Clerk provided Members with a reply received from Mr. Deryck Evans (Audit Manager), in relation to an audit report. The Clerk further provided chronological information together with replies from Freedom of Information requests to Audit Wales with one outstanding.

Members discussed at length together with other information received.

Members agreed the following: (1) The Clerk to write to Audit Wales to formally seek a further appeal by an independent panel (2) The Clerk to seek a number of further Freedom of Information requests from Audit Wales (3) The Clerk to further contact legal sources.

- (5) Memorial Institute Annual General Meeting: The Clerk advised that the meeting was listed to be held on Tuesday 10th October at 7.00pm. The Town Council's two Councillor representatives Councillors Lesley Roberts and Judith Standring had been notified. (It was noted that Councillor Standring would be on holiday).
- (6) Overhanging tree branches in area of public conveniences: The Clerk advised Members that a quotation had been received from Davies, Land & Sea (Lloc) for the removal of the tree branches which overhang into a neighbouring property had been received for the sum of £300.00 plus VAT. The quotation had been sent to the Mayor and Deputy for consideration, which had been accepted and a Work Order issued.

Members agreed the following: Confirmed the quotation from Davies Land & Sea at a cost of £300.00 plus VAT.

(7) Community Award: The Clerk advised that the two recipients named Sandra Evans and Roland Ward had confirmed their acceptance of the award. Whilst Roland Ward will attend the Civic Service to be presented with the award, Sandra Evans is not able to attend and will attend the November Council meeting to receive her award.

The Clerk to forward to Members a number of web site links for Councillors to consider the type of award to be presented.

(8) Pedestrian Safety on B5122 Road: The Clerk recollected Members to an e-mail received from Councillor Susan Broadaway who expressed her concerns for pedestrian safety on the hill travelling from Caerwys to Afonwen. The e-mail had been sent to a County Highways Officer, whereby the reply received had been forwarded to all Members.

The contractors to confirm their NICEIC (Electrical Qualification).

The Clerk advised that one contractor had supplied a quotation (viewed on screen) with one contractor confirming their above qualification.

7(B). 193/23 CLERK'S REPORT

- (a) The Clerk advised Members in relation to the following deposits to the Council's bank account:
- £13,750.00 Flintshire County Council: Second precept payment for financial year 2023 / 2024.
- (b) The Clerk discussed with Members the vehicle speed activated sign sighted almost opposite the Piccadilly Inn. This sign was installed by the Welsh Government some 12 to 14 years ago following complaints from this Council due to the substantial increase in traffic travelling to and from the Vale of Clwyd. Whilst the signage has not been faulty since installation, the actual bulbs are of a lower dimness when flashing the speed limit of 30mph. With the introduction of a 20mph speed limit on this road a few days ago, the Clerk enquired with Members as to the future of the signage.

Members agreed the following: To leave the sign in situ. The Clerk to place on the March 2024 agenda for review

(c) Councillor Andy Delooze reported to the Clerk damage caused by a vehicle apparently knocking into an electricity wooden pole in the area of the public conveniences in Drovers Lane. Photographs were supplied. The Clerk contacted the Flintshire County Council out of hours as both electricity and telephone wires were loosely dangling into the road. The incident was also reported to Scottish Power who attended and made safe.

The Clerk advised that the Flintshire County Council out of hours service is administered by a company in Carmarthenshire. This company telephoned the Clerk to advise that despite calling the Flintshire Out of Hours Officer for over two hours, the dedicated mobile phone was switched off. County Councillor Steve Copple provided further information.

(d) Proposed road works in South Street. Signage together with construction vehicles appeared in South Street without notification. Following enquiries made by County Councillor Steve Copple it appeared that new cabling was to be installed. The work will commence once the required permits have been agreed between the County and the contractor.

(e) STREET LIGHTING:

(1) The Clerk advised that during the street lighting inspections by Flintshire County Council, two lights were reported as faulty. Councillor Duggan-Keen was made aware of a lantern arm that had been found damaged – near the entrance to Ashgrove, North Street.

The two faulty lights had been rectified by Flintshire County Street Lighting, with the faulty arm replaced by this Council's street lighting contractor.

(2) Two faulty street lights reported by resident sited either side of the former Post Office on the A541 in Afonwen.

CO-OPTION OF A CAERWYS TOWN COUNCILLOR

The Clerk recollected Members to a Public Notice displayed on the Town Council's web site, public notice boards and the Caerwys Chronicle, advertising the vacant Councilor position, with a closing date of 12 noon on Friday 8th September. The Clerk advised that one application had been received. Members perused the written Expression of Interest which was shown on screen.

TO CONSIDER FURTHER: FLOODLIGHTING DURING WINTER MONTHS IN THE MULTI-USE GAMES AREA) (ADJ FROM MARCH MEETING)

The Clerk recollected Members to a previous decision whereby this Council covered the electricity cost to the Memorial Institute to enable the Multi-use Games Area to be floodlit during the winter months. The Clerk further recollected Members that it had been agreed at a previous meeting to review the funding for these winter's darker evenings.

Members agreed the following: To cover the electricity costs on a Friday and Saturday evening for two hours each. The timings to be altered as appropriate during the months from November to February. Councillor Lesley Roberts together with the Clerk to discuss at the Memorial Institute Annual General Meeting to be held on the 10th October.

The Clerk recollected Members that following the demolition of the Afonwen notice board Council agreed to consider the condition of the remaining notice boards in Caerwys and Pen Y Cefn.

Members agreed the following: (1) As the Pen Y Cefn notice board has recently been repaired, not to consider a replacement (2) The notice board in South Street Caerwys has been in situ for almost 20 years. The board leans with water ingress to both sections. The Clerk to seek a quotation from Apex Joinery (NW) Limited for a modern wooden notice board with the Council bilingual name on the top, together with other specifications.

The grass had been cut up to the edges of the pitch perimeter but not the actual pitch. This resulted in the pitch not being playable by the youths during the summer holidays. (Photograph supplied) and shown to Members on screen.
- (ii) Bus stop sign adjacent to Ashgrove, North Street, Caerwys. Reported as weathered with a replacement sought. (Photograph provided)

The Clerk provided the following update from Mr. Neil Hickie (StreetScene) Officer

• Football pitch adjacent to children's play area: The County are unable to synchronise the tractor with the other teams equipment due to schedules. Experiencing difficulties with the gang mower being off the road; this will be replaced and next season this should not be a problem.

Members brought the following concerns to the meeting:

- (1) South Street: Surface drain fully blocked (photograph attached)
- (2) High Street: Surface drain blocked (photograph attached)
- (3) Junction of Drovers Lane with Pen Y Cefn Road: Road sign badly rusted
- (4) Caerwys Hill to Afonwen: Majority, if not, all drains appear to be blocked. Surface water during rainfall flows over the drains which are full of grass
- (5) B5122 Road with junction to roundabout to A55 flyover (Dragon's Rest). Request for arrow markings right lane to drive straight ahead and left lane curved arrow to turn into slip road.

These arrows assist drivers and can be seen on the roundabout in Mold (Tesco) – travelling from the Wylfa area.

❖ The Clerk to invite Mr. Neil Hickie to the October Town Council meeting.

The Clerk advised that the above concerns would be brought to the attention of StreetScene.
