# TO APPROVE THE MINUTES OF THE MEETING HELD ON THE 20<sup>TH</sup> FEBRUARY, 2024

The Minutes were proposed as correct by Councillor Jonathan Duggan-Keen and seconded by Councillor Steve Copple and formally agreed by the Members present.

#### 6(A). 59/24

#### PROGRESS REPORT ON MATTERS RAISED AT PREVIOUS MEETINGS

The Clerk referred to the following matters from previous Minutes:

(1) Faulty street lantern in Afonwen: The Clerk advised that two quotations had been received as follows: To remove existing electricity supply cable from a Park View property and replace with new cable and attach to lantern - £2,200.00 plus VAT (Written permission would be required from the various properties). The second quotation to remove existing lantern and replace with solar lantern - £980.00 plus VAT.

Members agreed the following: (1) There is no statutory requirement to provide street lighting attached to residential properties (2) Due to the current financial climate, the Council agreed, at this time, not to complete work to rectify or replace the faulty lantern.

- (2) **Storage of outside Christmas illuminations:** The Clerk advised that despite a number of requests to the street lighting contractor, the Christmas illuminations had not been returned to Councillor Andy Delooze. The request to remain on file.
- (3) **Town Square Plaques:** The Clerk advised that the English wording on the Royal Charter and Millennium plaques sited on the Town Square had been sent to a Welsh translator in Ruthin. The bilingual translations have not yet been received back by the Clerk.
- **(4) Afonwen Notice Board:** The Clerk advised that a repair cost of £100.00 plus VAT had been received from Dylan Thomas (Joiner) for the damaged notice board.

Members agreed the following: Confirmed the above repair cost.

**Harp Project:** The Clerk advised in relation to another set-back to the planning application for the Harp project. Members perused on-screen an e-mail received from the Planning Officer allocated to the Council's planning application, which stated the following:

'In regard to land ownership and the discussions you had with Streetscene prior to submitting the application, I know it was the belief that the Council own the land because it's maintained by Streetscene, however after investigation we do not have any confirmation of land ownership for this piece of land. I have spoken to Streetscene and to Highways and land ownership could not be confirmed. The land is not showing as registered on the Land Registry either.

I have spoken to the Team Leader and we would request in this instance that you advertise in the paper allowing 21 days and then sign certificate D which forms part of the planning application (I have attached this for reference. You will find certificate D near the end). This will ensure that the process has been carried out properly and any potential landowner has the opportunity to come forward. There are no issues with the application except this so once this has been completed and hopefully no landowners come forward the decision can be issued.

In the meantime, I would be very grateful if you could confirm that you agree to an extension of time until 19/04/24 to allow the advertisement to be placed in the paper and for this to run it's course. Hopefully this can be sorted out relatively quickly but we cannot issue the decision until we are satisfied that all the appropriate steps have been carried out'.

The Clerk advised Members that he had agreed to the extension of time.

# TO RECEIVE REPORT: MEETING WITH HANNAH BLYTHYN MS, POLICE INSPECTOR IWAN JONES & ANTHONY STANFORD (FLINTSHIRE COUNTY COUNCIL)

The Clerk advised that the above meeting held on Friday 1<sup>st</sup> March in the Llys Y Goron Community Meeting Room was attended by the following: Hannah Blythyn MS (Welsh Government) / Louise Hughes (Case Worker: Office of Hannah Blythyn) / Inspector Iwan Jones (North Wales Police) / Anthony Stanford (Flintshire County Council - Highway Officer / Caerwys Town Councillors' Steve Copple (Deputy Mayor); Jonathan Duggan-Keen; Gwen Jones, together with R. Phillip Parry (Clerk to Caerwys Town Council).

Councillor Steve Copple provided the following notes from the meeting:

- (i) Provided historical background to parking concerns which were featured in a number of issues of the Caerwys Chronicle and Town Council minutes dating back to the 1970's to more recent.
- (ii) Provided details of the visit to a recent Town Council meeting by Hannah Blythyn which had discussed parking concerns in a number of areas in Caerwys.
- (iii) Outlined inconsiderate and contrary to the Highway Code illegal parking (within 10 metres of a junction and in areas of dropped kerbs) both on the B5122 road which runs through the Town, including a number of adjoining streets. Numerous photographs were viewed on screen of vehicles not adhering to the Highway Code.
- (iv) Councillors in attendance referred to the following concerns: An accident waiting to happen, many residents are elderly, mobility and wheelchair users, pedestrians and children regularly visit the Town Square area. The parking on street corners and in areas of dropped kerbs reduces the visibility for both pedestrians and motorists, in particular during egress from side streets. The introduction of parking restrictions would alleviate the inconsiderate and illegal parking of vehicles.
- (v) Police Inspector Iwan Jones advised that he would increase patrols in Caerwys and also arrange for a two week police presence and commence a programme of 'Watch your parking'.
- (vi) Anthony Stanford (Flintshire County Council Transport Manager), provided detailed information in relation to parking restrictions and in particular, a matrix used by the County to score areas for parking restrictions, including the legality and advertising

process. The County fund a limited number of parking restrictions during each year, whereby there are currently many areas on the waiting list. However, should the Town Council agree to fund the legal and advertising process at a cost in the region of £4,000.00, the County would provide the yellow line marking process at no cost. The County firstly would survey the areas to confirm the suitability for parking restrictions.

(vii) The Deputy Mayor, Councillor Steve Copple as Acting Chair of the meeting, thanked everyone for their attendance, and also thanked Hannah Blythyn MS for arranging the joint meeting.

Town Council Members discussed fully the information provided from the above meeting, with the Clerk providing details of current ear marked reserves and financial information.

**Members agreed the following:** (1) In principle, agree to finance the introduction of parking restrictions at an approximate cost of £4,000.00 (2) The Clerk to forward to Anthony Stanford a list of proposed street corner and junction areas adjacent to the B5122 road to be professionally assessed (3) The item to be placed on the April agenda.

The pupils were advised of Council business and participated in providing their response and votes in a number of Council areas including planning. A pictorial quiz was held and refreshments provided. The pupils were provided with a name badge and received an individual certificate with their names entered and signed by the Mayor. Following the visit the school had made contact with the Clerk and stated the following:

'The children had a wonderful time and were 'buzzing with enthusiasm' when we got back to school, enjoying telling their friends all about it.

It was such great experience for them to see how your meetings run but also for them to feel a part of their community and also see the 'behind the scenes' of their community, too. We had lots of other children saying they wanted to join the school council next year'!

# 7(C). 64/24 STREETSCENE SCHEDULE (FLINTSHIRE COUNTY COUNCIL)

# The Clerk advised in relation to the following concerns that had been reported to StreetScene, since the last Council meeting:

- ❖ Water leakage emanating at the junction of Drovers Lane and North Street.
- ❖ Four-way traffic lights during repair work to above water leakage were locked on red on all four units. This was reported to Flintshire Street Scene as urgent by the Clerk, it took the County four days to relay the fault to the contractor.
- ❖ Damaged wall on B5122 road travelling from Caerwys to Afonwen. Photographic evidence supplied with vehicle registration that was received from a member of the public.

The Clerk provided the following update from Mr. Neil Hickie (StreetScene) Officer

No update in relation to previously reported concerns had been received from Street Scene.

#### Members brought the following concerns to the meeting:

- (1) A541 Road in Afonwen: From the area of Maes Mynan traveling towards the Denbighshire border requires urgent attention. The carriageway has numerous defects, and an iron grating has a bad pot hole which could be very dangerous
- (2) Holywell Road: Potholes near junction with North Street
- (3) Cae Delyn: Grassed area damaged by heavy vehicles working in the area (photograph attached)

The Clerk advised that the above concerns would be brought to the attention of StreetScene.

#### TOWN MAYOR'S REPORT

The Town Mayor, Councillor Jayne Morris, advised Members of their attendance at the following:

A children's entertainer had been booked who had attended previous events in Caerwys with a cost of £200.00. The event would be for Cancer Research Charity with a local musical group also providing entertainment.

Members agreed the following: Were pleased to assist this charity event by providing funds of £200.00, for the payment to the children's entertainer.

**Potholes:** Point of discussion on rural potholes and next steps in terms of a broad multi ward approach on this aspect
