COMMUNITY AWARD PRESENTATION

TO APPROVE THE MINUTES OF THE MEETING HELD ON THE 15TH JULY 2025

The Minutes were proposed as correct by Councillor Jonathan Duggan-Keen and seconded by Councillor Steve Copple and formally agreed by the Members present.

PROGRESS REPORT ON MATTERS RAISED AT PREVIOUS MEETINGS

The Clerk referred to the following matters from previous Minutes:

- (1) Interpretation Board:** The Clerk advised that a further quotation had been received for an engraved bilingual plaque to be sited in the area of the Wooden Harp, which was shown on screen to Members: 800mm x 480mm at a cost of £1,048.00, delivery approximately £75.00 (Photocast) with consultative fee (Illustrative Mapping) of £100.00 (all plus VAT).

Members agreed the following: (1) Confirmed the above costs (2) The Clerk to make contact with the landowner to seek permission to secure the plaque to the stone wall adjacent to the Harp (3) If agreed, the Clerk to issue a Purchase Order.

- (2) Additional Christmas Lighting:** Following the resignation of Councillor Andy Delooze, the Clerk wished the Council to clarify their views in relation to the proposed additional Christmas lighting.

Members agreed the following: (1) Area of Drovers Lane with North Steet junction - To purchase battery operated lights to be placed on an existing tree in the area (2) Councillor Steve Copple to source the battery operated lights (3) The existing Reindeer lighting units to be relocated and placed around the Town Square tree (4) No Christmas lights in the area of the top of Caerwys Hill.

- (3) Emergency First Aid & Defibrillator Training:** The Clerk advised that following advertisement of the course to be held in Caerwys Town Hall on Friday 10th October, at 7.00pm – a number of bookings have been received.

CLERK’S REPORT

- (a) The Clerk advised Members in relation to the following deposit to the Council’s bank account:
 - £14,833.33 - Flintshire County Council: Second precept payment for financial year 2025 / 2026
- (b) The Clerk advised in relation to the resignation of Councillor Andy Delooze. A copy of the resignation had been provided to the Mayor and Deputy Mayor. The Clerk confirmed that a Public Notice under the Local Government Act, 1972 (Section 87(2)), had been sent to the Flintshire County Returning Officer, which had been acknowledged. The Public Notice is displayed on the Council’s notice board and web site.

Members agreed the following: The Clerk to write to retired Councillor Andy Delooze to express the Council’s and residents’ appreciation for his time as a Town Councillor.

- (c) Gwella (Flintshire County Council). Improvements commenced in the Multi Use Games Area in Chapel Street. The remaining agreed work and installations will take place during the autumn in the children’s play area.
- (d) Councillor John Johnson completed a One Voice Wales – New Councillor Induction virtual course.
- (e) The Clerk advised that the yellow lines had now been completed fully. Whilst the County had written to residents in South Street, the Clerk had hand delivered letters on behalf of the Town Council to advise of the date and request that vehicles be moved from the area. The work was to complete the yellow lines and re-paint the lines that had been painted over in black.
- (f) The Clerk advised that the Local Government Services Clerk’s pay agreement for 2025 / 2026 had been agreed. The Chair and Vice Chair had been sent a copy of the new salary scales.

Members agreed the following: (1) Accepted the new scale (2) Noted the back pay following deduction of HMRC included on the list of payments for this evening’s meeting (2) Authorised the Clerk’s salary standing order to reflect the increase per month.

- (g) The Clerk advised that he had attended a virtual One Voice Wales Bio-diversity course on Tuesday 9th September.
- (h) The Clerk advised in relation to the following correspondence received from the Flintshire County Council Tree Officer: The Christmas lights and control unit sited on the Town

Square tree are starting to pinch the bark, could the Council's lighting engineer adjust the wiring following the leaf fall. The Clerk has asked the lighting engineer to complete this work.

- (i) The Clerk advised that the bugler, Alun Rhys Jones, had confirmed their attendance at the Caerwys Remembrance Service on Sunday 9th November. The Clerk recollected to Members that the bugler did not wish any payment for their attendance and requests a donation to St. Kentigern be made.

Members agreed the following: To provide the St Kentigern Hospice with a donation of £50.00 – for the services of Alun Rhys Jones at the annual Caerwys Remembrance Sunday.

7(C). 188/25

TO REVIEW: ENVIRONMENTAL / GARDENING CONTRACT

The Clerk advised that the current environmental and gardening contract was agreed two years ago and is required to be reviewed. Members were shown on screen information received from Gaynor Griffith in relation to the renewal of the contract at a cost of £175.00 each month – an increase of £25.00, which included itemised work that is currently completed.

Members agreed the following: (1) To extend the contract for a further two years at a cost of £175.00 per month for ten months (no payments in January and February) with the first payment due in October this year (2) The Clerk to seek the views of Gaynor Griffith to complete additional work to be paid as extra hours for the following: Strimming of weeds in the Memorial Institute Walkway including Chapel Street and in the area of the St Michael's Church Lychgate on Pen Y Cefn Road (3) If agreeable, the Council would purchase a lightweight strimmer with an additional battery (4) Financial Standing Orders / Regulations were suspended in relation to obtaining at least one further quotation, for the following reasons: The contract cost per hour was reasonable; the Council and residents are appreciative of the work completed in ensuring the streets and flowers are a credit to the Town.

STREETSCENE SCHEDULE (FLINTSHIRE COUNTY COUNCIL)

The Clerk advised in relation to the following concerns that had been reported to StreetScene, since the last Council meeting:

- (1) Defaced 20mph signage on road known as The Nook to Bryn Aur (Reported by County Councillor Steve Copple)
- (2) Blocked gully causing flooding on A541 Road in Afonwen between the bus shelter and Fron Heulog

The Clerk provided the following update from Mr. Neil Hickie (StreetScene) Officer

- No update in relation to previously reported concerns had been received from Street Scene.

Members brought the following concerns to the meeting:

- (1) B5122 Road – Travelling out of Caerwys – Gully requires attention
- (2) B5122 Road – Top of Caerwys Hil – Service strip requires filling in (previously reported)

The Clerk advised that the above concerns would be brought to the attention of StreetScene.

Comment by Council: Whilst the Town Council have no objection to the application, as long as planning policies and planning guidance notes are complied with, however, there is concern with the size of the actual extension.

- (2) Application number: FUL/000725/25 - proposed removal of existing pitched roof to rear extension and replacement with flat roof and roof lights along with general opening re-

configuration, proposed additional windows in existing side elevation and change mono pitch roof to garage to dual pitch. General internal re-configuration, at Mount Pleasant, Holywell Road, Caerwys.

Comment by Council: No objection to the application, as long as planning policies and planning guidance notes are complied with.
