PUBLIC QUESTIONS, COMMENTS OR REPRESENTATIONS

- ❖ Concern received from resident in relation to speeding traffic along the B5122 Road in South Street. The resident had reported the concern to the North Wales Police who advised that the concern was the responsibility of Flintshire County Council. The Clerk had replied to advise the following:

The Police are partially correct that parking on yellow lines the enforcement aspect is within the remit of the Flintshire County Council - under the Civil Contravention (Civil Enforcement) - where the parking on yellow lines are treated as a civil offence under local authority management and a Penalty Charge Notice (PCN) can be issued. However, the following is within the Police jurisdiction: Under Section 22 of the Road Traffic Act 1988, Leaving a Vehicle in a Dangerous Position is an offence to leave a vehicle in such a position that it is likely to cause danger to other road users. Rule 243: Instructs drivers not to stop or park opposite or within 10 metres (32 feet) of a junction, or on a bend, to ensure clear visibility for all motorists. This is either with or without yellow parking restrictions in situ.

The Clerk clarified to the resident: The County Council issue a Penalty Charge Notice (PCN), whereby the Police issue a Fixed Penalty Notice (FPN). The resident was advised to continue reporting to the Police and to seek a reference number on each occasion.

Councillors Susan Broadaway and Jane Morris provided an update in relation to suggested play equipment. Richard Roberts (Play Design Officer) will provide Council with photographs of the suggested items together with costings for perusal by the Council Members.

The wooden bench seat in memory of Councillor Helen Priestly following installation requires additional secure fixing.

Members agreed the following: To seek a quotation from Gwella (Flintshire Leisure) to safely secure the bench seat.

- (2) Harp Interpretation Plaque:** Councillor John Johnson provided the following report. There was difficulty in securing the interpretation plaque to a stone wall given the uneven surface and secure fixings concern. The interpretation plaque has been sited on one of the tree guards; the board is now more visible. A photograph of the interpretation plaque in its new position was shown on screen.

- (a) The Clerk advised that the Annual Return for Year Ending 31st March 2026 had been submitted to Wales Audit. A Public Notice of appointment of the date for the exercise of electors' rights is displayed on the Council's notice board and uploaded to the Council's web site.

- (3) Street Name Plate for Holywell Road. *A works ticket has been raised and submitted to Service Delivery.*
- (4) Rocks on Verge South Street. *Glasfryn hall will be contacted to discuss the concerns raised by the Town Council. Will be proposed that the stones are removed – with arrangements for verge markers to be installed as to prevent vehicle encroachment.*
